He succeeds Fatima Berral, who, for twelve years, including seven as CEO, has driven strong organic growth and led strategic acquisitions that have expanded the Group's offering and strengthened its European footprint. Fatima Berral will now chair the Strategic Committee, a new governance body designed to support the overall Group strategy.

"I am proud of how far we have come together and confident in Antoine's ability to work alongside the teams to take the group's ambitions to new heights. As Sogelink enters this new chapter, I am handing over the reins in a spirit of continuity and with the desire to continue serving the Group through my role on the Strategic Committee," said Fatima Berral.

Antoine Dumurgier added, "I'm tremendously excited about the opportunity to join Sogelink. In addition to continuing the Company's strong organic growth trajectory, my immediate focus is on accelerating product innovation through recent advances in AI capabilities, and I look forward to improving the daily experience of the group's more than 220,000 users. I am very honored to be part of this new chapter in the Company's history and look forward to continuing its international expansion to make Sogelink the undisputed European leader in its fields."
